



## Editorial Changes—Report No. 15

### 1 January 2023–30 June 2023

1 In preparing compilations for registration during the above period, First Parliamentary Counsel made the following editorial changes under the *Legislation Act 2003*.

2 The summary of editorial changes for the 10 compilations affected is as follows:

4 Complete details of each use of the power within a compilation appears below:

### **Military Rehabilitation and Compensation Act Education and Training Scheme 2004, Compilation No. 6, Registration Date: 25 January 2023 [F2023C00088]**

#### **Paragraph 3A.10.1(1)(e)**

##### **Kind of editorial change**

Give effect to the misdescribed amendment as intended and change to typeface

##### **Details of editorial change**

Schedule 1 item 2 of the *Military Rehabilitation and Compensation Legislative Instruments Omnibus Variation Determination 2022* provides as follows:

- 2 **Paragraph 3A.10.1(1)(e)**  
Omit “disability pension”, substitute “a pension payable under Part II or IV of the VEA at a rate determined under or by reference to Division 4 of Part II of the VEA”.

The words “disability pension” do not appear in paragraph 3A.10.1(1)(e). However, the words “*disability pension*” do appear.

Italics is missing from the word “VEA” (twice occurring) in the substituted text.

This compilation was editorially changed to omit “*disability pension*” and substitute “a pension payable under Part II or IV of the *VEA* at a rate determined under or by reference to Division 4 of Part II of the *VEA*” in paragraph 3A.10.1(1)(e) to give effect to the misdescribed amendment as intended and change the typeface to bring it into line with legislative drafting practice.

## **Records Principles 2014, Compilation No. 16, Registration Date: 24 January 2023 [F2023C00124]**

### **Subparagraph 6C(2)(c)(c)**

#### **Kind of editorial change**

Renumbering of a provision

#### **Details of editorial change**

There is a subparagraph 6C(2)(c)(c) in the *Records Principles 2014*.

This compilation was editorially changed by renumbering subparagraph 6C(2)(c)(c) as subparagraph 6C(2)(c)(iii).

## **Veterans’ Entitlements (Direct Deductions Arrangements) Instrument 2015, Compilation No. 1, Registration Date: 24 January 2023 [F2023C00121]**

### **Paragraph (i) of Part 2**

#### **Kind of editorial change**

Change to punctuation

#### **Details of editorial change**

Schedule 4 item 4 of the *Veterans’ Entitlements Legislative Instruments Omnibus Variation Determination 2022* instructs to repeal paragraphs (j) and (k) of Part 2.

The repeal of paragraphs (j) and (k) results in paragraph (i) ending with a semicolon despite being the last paragraph of that part.

This compilation was editorially changed by omitting the semicolon and inserting a full stop at the end of paragraph (i) of Part 2 to bring it into line with legislative drafting practice.

**Federal Court (Corporations) Rules 2000, Compilation No. 19,  
Registration Date: 21 January 2023 [F2023C00113]**

**Schedule 1 (Form 7)**

**Kind of editorial change**

Change to punctuation

**Details of editorial change**

Form 7 of Schedule 1 contains the following text:

- 2 [If the deponent is not the creditor, state the facts entitling the deponent to make the affidavit, eg 'I am authorised by the creditor(s) to make this affidavit on its/their behalf].

This compilation was editorially changed to insert a closing quotation mark after “behalf” to correct the punctuation.

**Summary Authority Rules 2019, Compilation No. 1, Registration  
Date: 20 January 2023 [F2023C00098]**

**Paragraphs 15(a) and (b) (second occurring)**

**Kind of editorial change**

Renumbering of provisions

**Details of editorial change**

There are two paragraph 15(a)s and two paragraph 15(b)s in the *Summary Authority Rules 2019*.

This compilation was editorially changed by renumbering the second occurring paragraph 15(a) as paragraph 15(c) and the second occurring paragraph 15(b) as paragraph 15(d).

**Paragraph 28(c) (second occurring)**

**Kind of editorial change**

Renumbering of a provision

**Details of editorial change**

There are two paragraph 28(c)s in the *Summary Authority Rules 2019*.

This compilation was editorially changed by renumbering the second occurring paragraph 28(c) as paragraph 28(i).

## **Taxation Administration Act 1953, Compilation No. 195, Registration Date: 6 January 2023 [C2023C00006]**

### **Subsection 18-35(1AA) of Schedule 1**

#### **Kind of editorial change**

Give effect to the misdescribed amendment as intended

#### **Details of editorial change**

Schedule 4 item 35 of the *Treasury Laws Amendment (2022 Measures No. 3) Act 2022* instructs to omit “\*Seasonal Labour Mobility Program withholding tax” and substitute “\*labour mobility program withholding tax” in paragraph 18-35(1AA)(b) of Schedule 1.

The text “\*Seasonal Labour Mobility Program withholding tax” does not appear in paragraph 18-35(1AA)(b) of Schedule 1. However, the text does appear in subsection 18-35(1AA) of Schedule 1.

Schedule 4 item 35 of the *Treasury Laws Amendment (2022 Measures No. 3) Act 2022* commenced retrospectively from 1 July 2022. However, the editorial change powers cannot be exercised retrospectively (see section 15W of the *Legislation Act 2003*).

This compilation was editorially changed to prospectively apply the amendment to the text in subsection 18-35(1AA) of Schedule 1 and give effect to the misdescribed amendment as intended on the day this compilation was registered.

## **Sex Discrimination Act 1984, Compilation No. 44, Registration Date: 4 January 2023 [C2023C00003]**

### **Subparagraphs 48(1)(gaaa)(ii), (gaa)(ii) and (gc)(ii)**

#### **Kind of editorial change**

Changes to punctuation

#### **Details of editorial change**

Schedule 1 item 6 of the *Anti-Discrimination and Human Rights Legislation Amendment (Respect at Work) Act 2022* provides as follows:

### **6 At the end of paragraphs 48(1)(gaaa), (gaa) and (gc)**

Add:

; or (iii) subjecting a person to a workplace environment that is hostile on the ground of sex;

This amendment results in two semicolons at the end of subparagraphs 48(1)(gaaa)(ii), (gaa)(ii) and (gc)(ii).

This compilation was editorially changed to remove the extra semicolon at the end of subparagraphs 48(1)(gaaa)(ii), (gaa)(ii) and (gc)(ii) to bring them into line with legislative drafting practice.

## **Broadcasting Services Act 1992, Compilation No. 104, Registration Date: 3 January 2023 [C2023C00001]**

### **Clause 30 of Schedule 8 (heading)**

#### **Kind of editorial change**

Update to a reference of a law or a provision

#### **Details of editorial change**

This compilation was editorially changed to update a reference from “**Schedule 5 or 7**” to “**Part 9 of the *Online Safety Act 2021***” in the heading to clause 30 of Schedule 8.

## **Environment Protection and Biodiversity Conservation Regulations 2000, Compilation No. 24, Registration Date: 3 January 2023 [F2023C00002]**

### **Regulations 20.11 and 20.12 (headings)**

#### **Kind of editorial change**

Changes to typeface

#### **Details of editorial change**

The headings to regulations 20.11 and 20.12 refer to the “**Environment Protection and Biodiversity Conservation Amendment (Cost Recovery) Regulation 2016**” and the “**Environment Protection and Biodiversity Conservation Amendment (2022 Measures No. 1) Regulations 2022**”, respectively.

This compilation was editorially changed to italicise the instrument titles in the headings to regulations 20.11 and 20.12 to bring them into line with legislative drafting practice.

## **Royal Commissions Regulations 2019, Compilation No. 3, Registration Date: 3 January 2023 [F2023C00003]**

### **Section 4 (definition of *interim access period*)**

#### **Kind of editorial change**

Give effect to the misdescribed amendment as intended

#### **Details of editorial change**

Schedule 1 item 2 of the *Royal Commissions Amendment (Custody of Records) Regulations 2022* instructs to repeal and substitute the definition of *interim-access period* in section 4.

The definition of *interim-access period* does not appear in section 4. However, the definition of *interim access period* does appear.

This compilation was editorially changed to repeal the definition of *interim access period* and insert the definition of *interim-access period* in section 4 to give effect to the misdescribed amendment as intended.

## **Subsection 12(2)**

### **Kind of editorial change**

Correct a typographical error

### **Details of editorial change**

Schedule 1 item 14 of the *Royal Commissions Amendment (Custody of Records) Regulations 2022* provides as follows:

#### **14 Subsection 12(2)**

Omit “record of a listed Royal Commission may give a copy of the record to a person or body during the interim access period for the listed Royal Commission”, substitute “record of a listed Royal Commission, or a Royal Commission to which section 10 applies, may give a copy of the record to a person or body during the interim access period for the Royal Commission”.

Section 4 contains the definition of *interim-access period*.

In the substituted words, a hyphen is missing between “interim” and “access period”.

This compilation was editorially changed to insert a hyphen between “interim” and “access period” in subsection 12(2) to correct the typographical error.

## **Paragraph 12(3)(b)**

### **Kind of editorial change**

Give effect to the misdescribed amendment as intended and update to a cross-reference

### **Details of editorial change**

Schedule 1 item 18 of the *Royal Commissions Amendment (Custody of Records) Regulations 2022* provides as follows:

#### **18 Paragraph 12(3)(b)**

After “60N”, insert “or 60P”.

The text “60N” does not appear in paragraph 12(3)(b). However, the text “6ON” does appear. The inserted text refers to “or 60P” instead of “or 6OP”.

This compilation was editorially changed to insert “or 60P” after “6ON” in paragraph 12(3)(b) to give effect to the misdescribed amendment as intended and correct the cross-reference.

## **Sections 16 and 17 (headings)**

### **Kind of editorial change**

Changes to typeface

### **Details of editorial change**

The headings to sections 16 and 17 refer to the “**Royal Commissions Amendment (Witness Allowances) Regulations 2021**” and the “**Royal Commissions Amendment (Custody of Records) Regulations 2022**”, respectively.

This compilation was editorially changed to italicise the instrument titles in the headings to sections 16 and 17 to bring them into line with legislative drafting practice.
