#### About this list

#### Requirement to provide list for tabling

This list of legislative instruments has been prepared for laying before each House of Parliament in accordance with section 52 of the *Legislation Act 2003* (the LA).

This list sets out the legislative instruments that are due to sunset (that is, to be repealed by section 50, 51 or 51A of the LA) on 1 October 2020.

Under subsection 52(2) of the LA, the Attorney-General must arrange for this list to be laid before each House of the Parliament on the first sitting day of the House on or after 1 April 2019.

This list was up-to-date when prepared on 12 February 2019.

#### Structure of list

To assist the reader, the instruments are grouped by administering department, consistent with the Administrative Arrangements Order last amended on 28 August 2018.

If a department is not mentioned in the list, the department does not have any legislative instruments due to sunset on 1 October 2020.
